Transfer of work of Udyog Mitra
from SIAM to MIDC

PREAMBLE:

Udyog Mitra was constituted vide G.R. No. UVM-1979/(95428)/(2148/IND-14, dated 21st November 1979 with amendment vide G.R. dated 1st March, 1984 with the objective of providing assistance to entrepreneurs in seeking approvals sanctions from various departments/agencies and also to solve the difficulties of the industrial units operating in Maharashtra. The Udyog Mitra is functioning under the Chairmanship of the Development Commissioner (Industries) with the members listed below:

- Managing Director, SICOM Ltd.
- Managing Director, Maharashtra State Finance Corporation (MSFC)
- Chief Executive Officer, Maharashtra Industrial Development Corporation (MIDC)
- Managing Director, Maharashtra Small Scale Industries Development Corporation (MSSIDC)
- Member Secretary, Maharashtra Pollution Control Board (MPCB)
- Jl. Director (Industries) - Member Secretary

There has been change in the ownership pattern of SICOM Ltd. and hence, the question of transfer of work pertaining to maintenance of accounts etc. of the Udyog Mitra to a suitable State organisation was under consideration of the Government.

RESOLUTION:

The Udyog Mitra will continue its activities with the present set up and the nominee officers and staff should continue to be borne on the establishments of their parent organisations. The Udyog Mitra should be de-linked from SICOM and attached to MIDC. As such the work of maintenance of the accounts of Udyog Mitra will be henceforth done by MIDC with effect from 1st November, 2001.

The officers and staff should be governed by the rules of their parent organisations. The expenditure on account of staff, advertisement, publicity, books, publications, office equipment and stationery, wages and other related items should be incurred initially by MIDC and then shared evenly by the State level corporations, represented on the Udyog Mitra. The perquisites like conveyance, accommodation, residential phones enjoyed by the nominee officers prior to their posting in Udyog Mitra should be continued to be provided to them by their respective parent organisations, until further orders.
