PREAMBLE :-

According to the Government Resolution, Industries, Energy and Labour Department, No. DIC 1083/12258/(2757)/IND-18, dated the 25th February 1985, the General Manager of District Industries Centres (DICs) have been delegated powers to sanction seed money/margin money loans to tiny units upto Rs. 20,000 in ordinary cases and Rs. 30,000/- in the cases of backward class beneficiaries subject to the conditions laid down in State Aid to Industries Rule 1961.

The Government of India vide their letter No. DIC/2(2)81, dated the 14th August 1984, have modified the guidelines for sanctioning loan assistance under District Industries Centres Schemes, as seed money/margin money to tiny units located in semi urban and rural areas having population upto one lakh. According to this modified guidelines, the question of delegation of enhancement of powers for sanctioning loans more than the limits of Rs. 20,000 in ordinary cases and Rs. 30,000/- in the cases of backward class beneficiaries, was under consideration Government.

RESOLUTION :-

In view of the position explained in preamble Government is, therefore, pleased to delegate the financial powers to sanction seed money/margin money loans to tiny units upto Rs. 40,000 in ordinary cases and Rs. 60,000/- in the cases of backward class beneficiaries, to the District Advisory Sub Committee constituted under the Chairmanship of the Collector vide Government Resolution, Industries, Energy and Labour Department, No. SSI 1079/(1365)/IND-5, dated the 12th September 1979.

Government is also pleased to direct that the existing financial powers of the District Advisory Sub-Committee should be modified as indicated and to the extent shown in the statement accompanying this Government Resolution.
