Maharashtra has long been a cornerstone of India's economic growth and a leader in global trade. With a Gross State Domestic Product (GSDP) surpassing \$500 billion, the state is well-positioned to achieve its ambitious target of a \$1 trillion economy by FY28. As the second-highest exporting state in India, contributing 15.37% to national exports, Maharashtra continues to strengthen its global trade footprint. Recognizing the need for a dynamic export ecosystem, the Maharashtra Export Convention 2024-25 were conducted to empower businesses, promote exports, and unlock the state's full trade potential.

The Maharashtra Export Convention 2024-25, a workshop that is part of the 100-days initiatives, spearheaded by the Directorate of Industries, Maharashtra, in collaboration with key stakeholders, spanned across 35 districts (combined for Mumbai and Mumbai sub-urban) from December 2024 to January 2025. The convention featured a series of Export Promotion Workshops, providing businesses, entrepreneurs, exporters, and policymakers with valuable insights into export procedures, trade regulations, financial assistance, logistics, and compliance.

The state's top exports include Gems & Jewellery (22.84%), Engineering Goods (11.39%), Electronics & Electrical Components (17.30%), Chemicals (10.09%), and Pharmaceuticals (5.75%). With exports growing significantly across multiple districts, Maharashtra is leveraging its "Districts as Export Hubs" (DEH) strategy to drive localized export growth.

To accelerate export-led development, Maharashtra has implemented a robust Export Policy, focusing on:

- Strategic Partnerships with Export Promotion Councils (EPCs), DGFT, FIEO, EXIM Bank, and trade bodies to facilitate global market access.

- Technology Integration through e-commerce collaborations, digital platforms, and advanced supply chain solutions to enhance market reach.

- Brand Maharashtra Development through international trade fairs, buyer-seller meets, and digital branding initiatives.
